

End-User License Agreement for GOOMFI, M-FILES™ CONNECTOR FOR GOOGLE APPS™

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL:

This End-User License Agreement (hereinafter "EULA") for the GOOMFI, M-FILES™ CONNECTOR FOR GOOGLE APPS™ (hereinafter "Product") is a legal agreement between you (either an individual or a single entity) (hereinafter "You", or "Licensee") and Cloudpoint, Helsinki, Finland (hereinafter "Cloudpoint") for the Product, which may include associated software components, media, printed materials, and "online" or electronic documentation. By installing, copying, or otherwise using the Product, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and Cloudpoint, and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the Product.

The Product is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The Product is licensed, not sold.

1. GRANT OF LICENSE.

Subject to the terms of this EULA Cloudpoint grants you the right to install and use copies of the Product on your hardware running a validly licensed copy of the M-Files version, for which the Product was designed. Cloudpoint may from time to time provide updated versions of the Product to comply with updated versions of M-Files.

2. OTHER RIGHTS AND LIMITATIONS.

(a) Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on any and all copies of the Product.

(b) Distribution.

You may not distribute copies of the Product to third parties.

(c) Prohibition on Reverse Engineering, Decompilation, and Disassembly.

You may not reverse engineer, decompile, or disassemble the Product, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

(d) Rental.

You may not rent, lease, or lend the Product.

(e) Support Services.

E-mail support is included in the pricing. Other support arrangements are agreed separately. Any supplemental software code provided to you as part of the Support Services shall be considered part of the Product and subject to the terms and conditions of this EULA.

(f) Compliance with Applicable Laws.

You must comply with all applicable laws regarding use of the Product.

3. TERM AND TERMINATION

The license is valid for 12 months at a time.

Licensee may terminate the license term with a written notice given latest one (1) month prior to the end of the current term.

Without prejudice to any other rights, Cloudpoint may terminate this EULA if you fail to fully comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the Product in your possession, and Cloudpoint may terminate the service without notice.

4. COPYRIGHT

All title, including but not limited to copyrights, in and to the Product and any copies thereof are owned by Cloudpoint. All title and intellectual property rights in and to the content which may be accessed through use of the Product is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by Cloudpoint.

5. NO WARRANTIES

Licensee shall pay all license fees punctually as invoiced, either by IBAN bank transfer, or by PayPal.
